**P**ar lettres patentes du Roy, données à Fontainebleau le sixiesme jour d'octobre, l'An de grace mil six cens vnuze, & de nostre reigne le deuxiesme. Signées par le Roy en son conseil, Lardy, & les flées du grand sceau en circ jaune sur simple queuë, conformatues à d'autres preccé-  
dentes. Il est permis à Pierre Ballard Imprimeur de Musique de  
sa Majesté, d'imprimer, faire imprimer, vendre & distribuer  
toute sorte de Musique tant vocale qu'instrumentale, de quel-  
que Authent que ce soit: Faisans defauts à tous autres Li-  
braires & Imprimeurs de quelque condition & qualité qu'ils  
soyent, d'imprimer, faire imprimer, extraire partie d'icelle par  
quelque maniere que ce soit, ny mesme vendre ny distribuer en  
général ne particulier, les liures de Musique imprimés & à im-  
primer par l'edit Ballard, sans son congé & permission, sur peine  
de confiscation desdits liures, despends dommages, intérêts, &  
d'amende arbitraire: ainsi qu'il est plus amplement déclaré ci-  
dites lettres: nonobstant toutes lettres impetrées ou à impetrer  
à ce contraires. Sadi ce Majesté veut sans autre significati-  
on né formalité, l'extract d'icelles mis au commencement ou fin  
de chacun desdits liures estre tenuës pour bien & deuement si-  
gnifiées à tous qu'il appartiendra.
